8.2 Approved credit accounts are subject to settlement in full within fourteen days of invoice. A minimum value of £45.00 plus VAT is applicable on any single order. All other transactions are subject to immediate payment.

8.3 The Company reserves the right to charge interest at the rate of 10% on invoices that have not been settled within thirty days.
